Pursuant to Rule 7.1 of the Arkansas Rules of Criminal Procedure, the undersigned Affiant(s), being duly sworn, deposes and says that he has reason to believe that the above person has committed the offense violating **A.C.A. 5-64-419** Possession of Controlled Substance to wit; Methamphetamine, a Schedule II Controlled Substance, **A.C.A. 5-64-443** Theft by Receiving, under \$5000 over \$1000, **A.C.A. 5-64-443** Possession of Drug Paraphernalia, **A.C.A. 5-54-125** Fleeing,(Felony) against the peace and dignity of the State of Arkansas.

FACTS ESTABLISHING PROBABLE CAUSE

1. That this affiant is a duly sworn law enforcement officer and was acting in such capacity on or about the 14th day of January 2015.
2. That on or about the 14th day of January 2015 McCurtain County Deputies and Oklahoma Highway Patrol units were in pursuit of grey colored Chevrolet pick-up pulling a white cargo trailer with the C&M painted on the sides in red paint. The pursuit crossed into Arkansas on US Hwy 70. The pursuit turned north onto Stateline Road. The pursuit continued up Stateline Road Bellah Mine Road and at the intersection of Bellah Mine and Pine Ridge Road the pick-up did a U- turn. At this time McCurtain County Dispatch notified Sevier County that the pick-up attempted to ram a Mc Curtain County unit. The pursuit then traveled west to Kellum Road and turned north onto Kellum Road. At the intersection of Kellum and Mountain Road an Oklahoma Highway Patrol unit left the roadway and came to rest next to the fence. The pursuit continued north on Kellum for several miles and at the intersection of Kellum and Deer Road the pick-up attempted to make another U-turn. At this time a McCurtain County unit hit the pick-up. The pursuit was ended and the driver and passenger were taken into custody by the Mc Curtain County Deputies. Sevier County Chief Deputy Chad Dowdle and Deputy Chris Wolcott arrived on scene at the time the occupants were taken into custody.
3. That the driver was identified as Clay Paul Denny and the passenger was identified as Rhonda Mc Combs. Investigator Robert Gentry arrived on scene a short time later. Deputy Wolcott was checking Clay Denny's person before placing him in the backseat of Gentry's vehicle. The following items were located in Clay Denny's pockets; a knife, clear plastic bag with suspected Methamphetamine(2.2 grams), Syringe, Altoids can with 2 pills and a Scan Disk SD card, \$59 and cell phone. Clay Denny told Deputy Wolcott what was in his pockets before taking them out. Investigator Gentry collected the items in a bag. Investigator Robert Gentry advised Clay Denny of his Miranda Rights using a Sevier County Miranda Rights form. Denny verbally acknowledged each Right and waived his Rights to

an attorney. Denny admitted that the trailer he was pulling was stolen and that it contained items that were stolen as well. Denny also advised that he had a loaded syringe in his hand at the time he exited the vehicle on the passenger side and wanted to help Investigator find the syringe. Investigator Gentry verbally read Consent to Search form to Clay Denny and he signed the form giving his Consent to Search of the vehicle. A search of the area around the time of arrest and no syringe was found. A search of the inside of the vehicle Investigator Gentry found the loaded syringe stuck in the passenger seat as well as a glass smoking device in the driver's side floor. Investigator Gentry loaded Clay Denny in his patrol vehicle and transported him to the Sevier County Detention Center. Bakers Wrecker Service transported the pick-up and trailer to the Sevier County Detention Center.

4. That a search of the trailer and the pick-up was conducted at the Sevier County Detention Center in the presence of Clay Denny. Arkansas State SA Hayes McWhirter, Sgt Ray Gentry and Investigator Robert Gentry conducted the search. Sgt. Ray Gentry photographed the items as they were identified by Clay Denny as either being stolen or belonging to Denny. There was items discovered that Denny admitted to have stolen from Little River and Lafayette Counties in Arkansas, Bowie and Cass Counties in Texas.
5. That Investigator Gentry will submit the substance to the Arkansas State Crime Laboratory for a complete chemical analysis.
